India's eight key primary residential markets witnessed appreciating property prices during the Jul-Sep 2023 period. Ahmedabad (6.1%), Bengaluru (8.2%), Chennai (1.8%), Delhi (1.8%), Hyderabad (6.8%), Kolkata (9.1%), Mumbai (3.6%) & Pune (6.1%) recorded increase in the index on an annual basis as per the Housing Price Index published by National Housing Bank.

The 50 city HPI based on valuation prices of properties collected from Banks and Housing finance companies (HPI @Assessment Prices) recorded an annual increase (Y-o-Y) of 4.9% during the 2nd quarter of the fiscal 2024 as compared with 7.4% a year ago.

The annual change in HPI @Assessment Price varied widely across the cities - ranging from an increase of 18.7% (Greater Noida) to a decline of 14.3% (Navi Mumbai). Out of the 50 cities covered. 41 registered an increase in property prices whereas 9 cities registered a decline in the property prices. The home loan rates are catching up with the pre pandemic rates. HOUSING PRICES RISE IN 41 CITIES IN Q2 FY 2023-24: NHB

India's eight key primary residential markets witnessed appreciating property prices during the Jul-Sep 2023 period. Ahmedabad (6.1%), Bengaluru (8.2%), Chennai (1.8%), Delhi (1.8%), Hyderabad (6.8%), Kolkata (9.1%), Mumbai (3.6%) & Pune (6.1%) recorded increase in the index on an annual basis as per the Housing Price Index published by National Housing Bank.

The 50 city HPI based on valuation prices of properties collected from Banks and Housing finance companies (HPI @Assessment Prices) recorded an annual increase (Y-o-Y) of 4.9% during the 2nd quarter of the fiscal 2024 as compared with 7.4% a year ago.

The annual change in HPI @Assessment Price varied widely across the cities - ranging from an increase of 18.7% (Greater Noida) to a decline of 14.3% (Navi Mumbai). HOUSING PRICES RISE IN 41 CITIES IN Q2 FY 2023-24: NHB

India's eight key primary residential markets witnessed appreciating property prices during the Jul-Sep 2023 period. Ahmedabad (6.1%), Bengaluru (8.2%), Chennai (1.8%), Delhi (1.8%), Hyderabad (6.8%), Kolkata (9.1%), Mumbai (3.6%) & Pune (6.1%) recorded increase in the index on an annual basis as per the Housing Price Index published by National Housing Bank.

The 50 city HPI based on valuation prices of properties collected from Banks and Housing finance companies (HPI @Assessment Prices) recorded an annual increase (Y-o-Y) of 4.9% during the 2nd quarter of the fiscal 2024 as compared with 7.4% a year ago.

The annual change in HPI @Assessment Price varied widely across the cities - ranging from an increase of 18.7% (Greater Noida) to a decline of 14.3% (Navi Mumbai). Out of the 50 cities covered. 41 registered an increase in property prices whereas 9 cities registered a decline in the property prices. The home loan rates are catching up with the pre pandemic rates. On a sequential (Q-o-Q) basis, the 50-city index registered an expansion of 1.3% in Jul-Sep 2023 as against 0.7% in the previous quarter. রিপোর্ট অনুযায়ী, গত কয়েক বছরে এরাজ্য আন্তর্জাতিক মাদক পাচারের ক্ষেত্রে অন্যতম গুরুষপর্ণ ঘাঁটি হয়ে দাঁডিয়েছে। কলকাতা পলিশ বা রাজ্য গোয়েন্দা দফতর সিআইডির মাদক বিরোধী শাখা থাকলেও, বাস্তবে পর্যাপ্ত আধিকারিক, কর্মী ও পরিকাঠামোর অভাবে অনেকাংশই নিষ্ক্রিয়। তাই রাজ্যের প্রথম মাদক বিরোধী বিশেষ টাস্ক ফোর্স গড়তে চায় রাজ্য সরকার। নবান্ন এব্যাপারে সবুজ সংকেত দিলেও লোকবল ও পরিকাঠামোর অভাবে এই মাদক বিরোধী বিশেষ টাস্ক ফোর্স এখনো গড়ে উঠতে পারেনি। কলকাতা পুলিশ ও রাজ্য পুলিশের স্পেশাল টাস্ক ফোর্স এখন বড়ো মাপের মাদক বিরোধী শাখা চালায়। গত ১ বছরে গাঁজা, ব্রাউন সুগার থেকে শুরু করে নিষিদ্ধ কাফ সিরাপ বা ইয়াবার মতো মাদক পাচার রোধে রাজ্য ও কলকাতা পুলিশের স্পেশাল টাস্ক ফোর্সের আধিকারিকরা বেশ কয়েকটি বড়ো সাফল্য পেয়েছেন। তবে মাদকের এই রমরমা বন্ধ করতে কলকাতা ও রাজ্য পুলিশের টাস্ক ফোর্সের সীমাবদ্ধতাও

কন্টোল ব্যুরোর আদলে শুধু মাদক বিরোধী বিশেষ টাস্ক ফোর্স গড়ার পরিকল্পনা করেন রাজ্য পুলিশের শীর্ষ কর্তারা। নারকো টেররিজম অর্থাৎ মাদক বিক্রির টাকা জঙ্গি কার্যকলাপে যে লগ্নি হচ্ছে না এই কথাও জোর গলায় বলতে পারছেন না গোয়েন্দারা। তাই ১জন পুলিশসুপার পদমর্যাদার আধিকারিকের নেতৃত্বে ২জন ডেপুটি পুলিশসুপার, ২জন ইন্সপেক্টর, ১৬ জন সাব ইনস্পেক্টর ও ১৫০ জন কনস্টেবলকে নিয়ে নতুন বাহিনী তৈরির খসড়া পাঠানো হয়েছে নবান্নে। রাজ্য পুলিশের এক কর্তা জানান, '২ভাবে এরাজ্যকে মাদক পাচারের করিডর হিসাবে ব্যবহার করা হচ্ছে। ইয়াবা থেকে শুরু করে নানা সাইকোট্রপিক ড্রাগের কাঁচামাল প্রতিবেশী বাংলাদেশ থেকে শুরু করে এশিয়ার নানা দেশ ঘুরে চোরাপথে এ রাজ্য থেকে পৌঁছে যায় মণিপুর, নাগাল্যান্ডের লাগোয়া মায়ানমারে। পরে সেখান থেকে তৈরি হওয়া মাদক ফের মায়ানমার সীমান্ত পেরিয়ে মণিপুর আর নাগাল্যান্ডের মাদক পাচারকারীদের হাত ঘুরে চলে আসে



ফের এরাজ্যের পথে। সেই মাদকের একটা অংশ পাচার হয় পড়শি বাংলাদেশে, বাকিটা ছড়িয়ে যায় এদেশের নানা প্রান্তে। দ্বিতীয় রুট হচ্ছে, ব্রাউন সুগার বা হেরোইনের। মায়ানমার আর উত্তর পর্ব ভারতের নানা জঙ্গি গোষ্ঠীর সক্রিয় মদতে মায়ানমার সীমান্তের প্রত্যন্ত পার্বত্য এলাকায় যে আফিম চাষ হয় সেই আফিম থেকে একদম প্রাথমিক-নিম্নমানের ব্রাউন সুগার তৈরি হয়ে চলে আসে এরাজ্যে। অন্যদিকে, পঞ্জাব আর রাজস্থানের লাগোয়া পাক-ই-স্তান সীমান্ত ধরে যে উচ্চমানের হেরোইন চোরাপথে ভারতে ঢোকে তার একটা বড়ো অংশ মায়ানমারের নিম্নমানের হেরোইনের

মিশিয়ে বাজারজাত করা হয়। মাদক পাচারের ক্ষেত্রে এই রাজ্যকে পাচারকারীদের একটা বড়ো অংশ ট্রানজিট হাব হিসাব ব্যবহার করছে। এসটিএফের অভিযানে বর্ধমান শহরে বসে নিম্নমানের মরফিন থেকে হেরোইন তৈরির ল্যাবরটরিরও হদিশ মিলেছে। গত এক বছরে প্রায় ৪০টি বড়ো অভিযানে ৩০ কোটি টাকা মূল্যের মাদক বাজেয়াপ্ত করেছেন স্পেশাল টাস্ক ফোর্সের আধিকারিকরা। রাজ্য পুলিশের এক কর্তা বলেন, 'স্পেশাল টাস্ক ফোর্স সাফল্য পেলেও জঙ্গি-নাশকতা বিরোধী অভিযান থেকে শুরু করে জাল নোট ও অর্গানাইজড

আর পর্যাপ্ত লোকবলও দরকার যাতে ক্ষেত্রে নবান্ন অন্ধকারে রাজ্য পুলিশ কর্তারাও।

অভিযানের দায়িত্ব রয়েছে। মাদক বিরোধী অভিযান অনেক সময় সাপেক্ষ চক্রের মাখা পর্যন্ত পৌঁছোনো যায়। সূত্রের খবর, সাম্প্রতিক অতীতে মাদক পাচার রোধে সাফল্য মিললেও, চক্রের মাথা পর্যন্ত পৌঁছোনোর জন্য যে দীর্ঘ তদন্ত দরকার তাতে বার বার লোকবলের অভাবে খামতি লক্ষ্য করা গেছে। এসব কারণেই বিশেষবাহিনী নীতিগতভাবে সবুজ সংকেত মিলেছে বলে দাবি রাজ্য পুলিশের শীর্ষ কর্তাদের। তবে এই বিশেষ মাদক বিরোধী টাস্ক ফোর্স বাহিনী করে তৈরি করা সম্ভব হবে তা নিয়ে সংশয় রয়েছে তার পেছনে একাধিক কারণ রয়েছে যেমন, প্রয়োজনীয় আধিকারিক আর পুলিশকর্মীর অভাব, মাদক বিরোধী অভিযানের জন্য প্রযক্তিগত পরিকাঠামো দরকার। দরকার রয়েছে মাদক চিহ্নিত করতে পারা পারদর্শী বিশেষ কুকুরবাহিনী। আর দরকার রাজ্য ফরেনসিক ল্যাবরেটরির সহায়তা। এসব কিছু ঠিক কবে মিলবে তা নিয়ে

ভাস্কর বিশ্বাস, হাওড়া : চাতরা ও মুরারাই স্টেশনের মধ্যে তৃতীয় লাইন তৈরির কাজ নিয়ে বৃহস্পতিবার হাওড়ায় সাংবাদিক বৈঠক করেন হাওড়ার ডিআরএম সঞ্জীব কুমার। সেখানেই তিনি জানান, রবিবার ১০ ডিসেম্বর থেকে চাতরা ও মুরারাইয়ের মধ্যে তৃতীয় লাইনের কমিশনিং কাজ হবে। তিনি রামপুরহাট সাহেবগঞ্জ বিভাগে পরিকল্পিত প্রাক-নন-ইন্টারলকিং ও নন-ইন্টারলকিং কাজ নিয়েও তথ্য প্রদান দেন। এদিন পূর্ব রেলের মুখ্য জনসংযোগ আধিকারিক কৌশিক মিত্র বলেন, 'হাওড়া ডিভিশনে চাতরা থেকে মুরারাই স্টেশন পর্যন্ত ৭.৫ কিমি লাইনে মেরামতির কাজের জন্য কিছু ট্রেন বাতিল থাকবে, কিছু ট্রেনের যাত্রাপথ সংক্ষিপ্ত করা হবে, কিছু ট্রেন ঘুরপথে যাবে আর কিছু ট্রেনের যাত্রাশুরুর সময় বদল হবে। মূলত এই সেকসন দিয়ে পণ্যবাহী ট্রেন চলাচল করে। এখানে অনেকগুলো পাওয়ার প্ল্যান্ট আছে, সিমেন্ট কারখানা আছে। যাদের কয়লা, সিমেন্ট বা কাঁচামাল ওই সেকসন দিয়ে পাঠানো হয়। এই থার্ড লাইন কাজ শেষ হলে পণ্য পরিবহণ পরিষেবা আরো বেশি উন্নত হবে এই কারণে আপাতত ৫ জোডা ট্রেন বাতিল করা হয়েছে। হাওডা-মালদহ ইন্টারসিটি এক্সপ্রেস, হাওডা-জয়নগর এক্সপ্রেস, হাওড়া-আজিমগঞ্জ কবিগুরু এক্সপ্রেস, হাওড়া-গয়া এক্সপ্রেস বাতিল করা হয়েছে। শিয়ালদহ-আলিপুরদুয়ার কাঞ্চনকন্যা এক্সপ্রেসকে ঘুরপথে নিয়ে যাওয়ার চিন্তাভাবনা হয়েছে। এছাড়া রাধিকাপুর এক্সপ্রেস, মালদহ গৌড় এক্সপ্রেস, শিলচর কাঞ্চনকন্যা এক্সপ্রেস, হলদিবাড়ি এক্সপ্রেস, উত্তরবঙ্গ এক্সপ্রেস, বালুরঘাট এক্সপ্রেস, যোগবানী এক্সপ্রেস, দার্জিলিং মেল ভায়া ব্যান্ডেল, কাটোয়া সেকসন দিয়ে ঘুরিয়ে দেওয়া হচ্ছে। তবে বন্দেভারত এক্সপ্রেস, নিউ জল্পাইগুড়িন শতাব্দী এক্সপ্রেস, শিয়ালদহ আলিপুরদুয়ার পদাতিক এক্সপ্রেস, জামালপুর এক্সপ্রেস, ভাগলপুর যাওয়ার জন্য বনাঞ্চল এক্সপ্রেস, হাওড়া আজিমঞ্জ গণদেবতা এক্সপ্রেস এই ট্রেনগুলি বাতিল করা হচ্ছে না। নির্ধারিত সময় অনুযায়ী এই ট্রেনগুলো যাবে। কিছু ট্রেনের সময়ের বদল করা হয়েছে।

মিগজৌমের কোপে ভাসল বর্ধমান আদালতের কক্ষ, চাষিরাও বিপাকে

বিপুন ভট্টাচার্য, বর্ধমান ও সুমনকুমার দাস, খড়গপুর: মিগজৌমের প্রভাবে গত ২দিন ধরে একটানা বৃষ্টির জেরে বৃহস্পতিবার বর্ধমান সাব ডিভিশনাল জুডিশিয়াল ম্যাজিস্ট্রেট আদালতের কক্ষ জলে ভরে যায়। অনবরত ছাদ থেকে জল পড়ার জেরে আদালতের গুরুষপূর্ণ নথি নষ্টের আশঙ্কা করেছেন আইনজীবীরা। বর্ধমান আদালতের আইনজীবী সিদ্ধার্থশঙ্কর তা জানান, বর্ধমান আদালতের এটা এক গুরুষপূর্ণ দফতর। এখানে ১৪৪ ধারা সহ নানা কেসের নথি রয়েছে। যেভাবে ছাদ থেকে হুড়মুড়িয়ে জল পড়ছে তাতে ওই সব নথি নষ্ট হওয়ার সম্ভাবনা রয়েছে। আদালতের কর্মীরা জানান, 'অনেকবার প্রশাসনিকভাবে এব্যাপারে অভিযোগ জানানো হয়েছে। কোনো সুরাহা হয়নি। এই ভবনটি অনেক পুরোনো। এভাবে ছাদ থেকে জল পডায় যেকোনো সময়েই হুড়মুড়িয়ে ছাদ ধসে যেতে পারে। একইসঙ্গে বিদ্যুৎ বিপর্যয়ও ঘটে যেতে পারে।' অন্যদিকে, মিগজৌমের কারণে পশ্চিম মেদিনীপুরেও চাষের ব্যাপক ক্ষতি হয়েছে বলে আশঙ্কা চাষিদের। বুধবার বিকেল থেকে নাগাড়ে বৃষ্টির পর বৃহস্পতিবার ভোররাত থেকে ফের বৃষ্টি হয়েছে। লাগাতার বৃষ্টিতে জমিতে জল জমে সদ্য লাগানো আলু ও পাকা ধানের ক্ষতি হয়েছে। অকাল বৃষ্টির জেরে মাথায় হাত গড়বেতা, শালবনী, মেদিনীপুর প্রভৃতি এলাকার চাষিদের। চাষে ব্যাপক ক্ষতির আশঙ্কা করছেন কৃষকেরা। জেলা উপ কৃষি আধিকারিক দুলাল দাস অধিকারী বলেন, 'জেলায় ৭৫% ধান কাটা হয়ে গেছে। অল্প ধান জমিতে রয়েছে। তাই ব্যাপক ক্ষতির আশঙ্কা নেই। তবে শস্যবিমায় নথিভুক্ত কৃষকেরা ক্ষতিগ্রস্ত হলে তাঁরা ক্ষতিপূরণ পাবেন। আলু চাষের ক্ষেত্রে শস্যবিমায় চাষিরা এখন নাম নথিভুক্ত করলে ক্ষতিপূরণ পাবেন।
