- iii. Date and time of end of "Remote e-voting" : Sunday, 6th August, 2023 at 5:00 P.M.(same day)
- iv. Cut-off date for E-Voting : Monday, 31st day of July, 2023
- v. Remote E-voting shall not be allowed beyond 5:00 P.M. on Sunday, 6th August, 2023.
- vi. Any person, who acquires shares of the Company and become member of the Company after dispatch of the notice and holding shares as of the cut-off date i.e. 31st day of July, 2023, may obtain the login ID and password by sending a request at helpdesk.evoting@cdslindia.com or jtaparia2008@gmail.com However, if you are already registered with CDSL for remote e-voting then you can use your existing user ID and password for casting your vote. - vii. The members who have casted their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.

The facility for venue voting shall be made available at the meeting and the members who have not casted their vote by remote e-voting shall be able to attend the AGM and vote by use of Venue Voting.
